After deciding that transfers of title of real property can be accomplished by agreement between the parties, we next must consider whether the agreement in the case sub judice was sufficient to transfer the title to the joint accounts from the grantor-grantees to the survivor-beneficiaries. The survivor-beneficiaries argue that the mutual wills executed by their parents were

executed under the impression that they would be beneficiaries of the accounts and that the parties intended that the survivor-beneficiaries would be the beneficiaries of the accounts upon the death of the survivor. Based upon this argument the survivor-beneficiaries contend that the mutual wills provided sufficient constructive notice that the terms of the agreement were being made for the benefit of the survivors. We agree with the survivor-beneficiaries' contention. We have already determined that the mutual wills were executed in contemplation of death and that the parties thereby intended the survivor-beneficiaries to be designated as

joint tenants on the death of their parents. The whole purpose of executing mutual wills is to designate certain assets to be held for the benefit of designated beneficiaries in case one of the parties dies. This consideration is sufficient to effect the transfer of title to the joint accounts from the grantor-grantees to the survivors. It is not necessary to consider evidence of constructive notice of title to real property. We therefore hold that the trial court erred in ruling that the grantor-grantees owned all the property in the joint accounts prior to the death of their parents. We have also considered the survivor-beneficiaries' argument that the trial court erred in failing to rule that the

survivor-beneficiaries own one-half of the accounts as *693 joint tenants with the grantor-grantees, and we find this argument without merit.

We recognize that it is the responsibility of the trial court to render a judgment which disposes of the issues before the court, and we cannot agree that the judgment in this case disposed of any of the issues raised by the pleadings. The agreement could not be read and considered as anything but an agreement to hold the joint accounts in trust for the survivor-beneficiaries. Whether the agreement 3e33713323
